



One of the key railway lines of Ukraine within the South-Western Railway passes through the territory of the Velyka Dymerka settlement territorial community (stations: Parnykova, Dymerka, Zherdove, Bobryk, and Semypolky).




The territory of the community is also crossed by the international highway E95 (Saint Petersburg – Homiel – Kyiv – Odesa – Samsun – Merzifon) and the national road H-07 (Kyiv – Sumy – Yunakivka).



A network of public bus routes has been established to meet the community's passenger transportation needs.

Velyka Dymerka Settlement Territorial Community is one of the three largest communities in Brovary District by area and the second largest after Brovary Urban Community by population.











Population Distribution within the Community

Social Infrastructure

The population density in the community is at the regional average level and is slightly higher compared to neighboring communities, which naturally impacts the social infrastructure network. Compared to other communities, Velyka Dymerka is characterized by a well-optimized network of educational and cultural institutions.





The healthcare network of the Velyka Dymerka TC consists of 10 outpatient clinics and 2 feldsher-obstetric points (FAPs), which provide primary healthcare services and are subordinate to the Public Non-Profit Enterprise (KNP) "Center of Primary Health Care" of the Velyka Dymerka Settlement Council. There is a need for energy efficiency improvements in primary healthcare facilities. Almost all of the buildings where these services are provided are very old, including one wooden outpatient clinic that is already 110 years old. As a result, the community incurs significant costs for utility services.

Natural Resource Potential



Climate.

Velyka Dymerka Settlement Territorial Community is located in a moderately continental climate zone with distinct seasons. Summers are warm and humid, while winters are mild. The average temperature in the coldest month, January, is –6.3°C, while in the warmest month, July, it reaches +19.5°C. The recorded minimum temperature is –35°C, and the maximum is +39°C. The duration of the period with temperatures above +10°C is 155–160 days. Prevailing winds come from the northwest. The average annual precipitation is 620 mm, with two-thirds falling during the warm season.



Water Resources.

The territory of the Velyka Dymerka TC is located within the Dnipro River basin. The rivers Trubizh, Bezimenna, Stav, and Krasylivka run directly through the community. In addition, the area contains over 30 small lakes, ponds, and technical water bodies. Water supply for both the population and local businesses is provided from surface and underground sources, including wells and boreholes. Most of the operating boreholes are owned by industrial and agricultural enterprises. A local division of IP "Coca-Cola Beverages Ukraine Limited" operates six boreholes within the community. Water erosion is not a significant concern in the area.



Soil Characteristics.

According to the SuperAgronom.com portal, the territory of the Velyka Dymerka TC contains the following soil types: dark gray podzolized soils, light gray podzolized soils, sod-podzolic sandy loam and loamy soils, meadow soils, and peat-bog soils. The soils in the Velyka Dymerka TC are classified as moderately fertile. On a 100-point scale, their fertility rating ranges from 52 to 66 points.



Mineral Resources.

The territory of the community contains the following mineral resources:


- Sand suitable for all types of construction work
- Clay used for brick production
- **Peat** applicable for heating and as a fertilizer in agriculture.

Land Resources

Structure of the Land Fund

The total area of the land fund of the Velyka Dymerka Settlement Territorial Community is 23,253 hectares. The structure of the land fund is as follows:

- Agricultural lands: 14,143 hectares (60.82% of the total land area), with the majority being arable land (12,246 hectares).
- Forests: 4,449 hectares (approximately 19.14%)
- Transport and communications: 655 hectares (2.82%)
- Residential development: 3,937 hectares (about 16.9%)
- Industry: 64 hectares (0.28%)
- Water Fund Lands: 0.04% of the total land area




This structure reflects a high degree of cultivation, with significant land reserved for residential development, industrial activities, and ecological preservation through forests.

Agro-industrial complex

In 2023, 49 agricultural enterprises were engaged in economic activities within the community. As of April 1, 2024, 11 farming enterprises were registered in the community. The development of agriculture in the community is supported by factors such as the significant amount of agricultural land, favorable climatic conditions, and the territorial proximity to the largest market in Ukraine. The largest budget-forming enterprises include LLC "MEGA MANAGEMENT PROJECT", CJSC "VOYTOVSKE", LLC "Iveria Agro", LLC "STOR-Agro", FG "Zhuravushka", and LLC «ASKANIA-FLORA".

An educational space has been arranged, renovations have been carried out in the cultural center building in the village of Bohdanivka, and the Community Development Strategy has been developed.



The creation of a safe educational space, arrangement of shelters, and support for distance learning.
